The APC Generosity Fund provides short-term financial assistance to APC Members and congregants who have been regularly attending for a period of at least 12 months. This financial assistance is primarily to help with food/groceries, rent, children's tuition fees, and part payment of medical expenses, if there is a temporary loss of job or no income to the household due to other reasons. Financial assistance will not be given if the household already has income. Financial assistance will not be given towards clearing of outstanding loans, purchase of vehicles or other purposes not in the primary areas mentioned earlier.

Your application will be reviewed by a five-member review team and a response on their decision will be provided by email. If approved, we will contact you to receive bank details to which funds will be remitted.
